Support for Vulnerable GP Practices Pilot Programme

The LMC is actively involved in working with NHS England and the 3 local CCGs on the implementation of this programme of support

for practices identified as being in difficulty the criteria NHSE are using are set out on pages 8-9 of the national document which can be accessed at:

There is £778,934 available to the practices covered by NHS England Central Midlands (Leics, Rutland, Lincs, Northants, Beds & Herts).

You can expect a letter from your CCG this week, setting out the local approach and giving you the opportunity to put yourselves forward for consideration. Each CCG has an overview of their practices and will be using the data they already have from various sources (e.g. contract quality monitoring, premises reviews, CQC reports, various local schemes). However, the LMC thought it would be helpful for practices to flag up any issues that are affecting the long term viability of their practices that the CCG or LMC may not be aware of.

There will be more work done a little further ahead in the process to look at solutions and commission the right support for practicesearly indications suggest this will be done at a local level, rather than a top-down, 'one size fits all' approach.

We understand this programme by no means addresses all of the issues practices face, and we note there is a requirement 'match' fund any resources allocated 50:50.



Reminder – the CQC's fees increase consultation closes on 15 January

Back in November the CQC launched a public consultation on how they charge the providers for being registered. Because the government has reduced their budget and directed them to fully cover their costs, they plan on increasing the annual registration by a significant percentage; for example they are proposing that the annual registration fee to a single location GP practice with between 5,000 and 10,000 patients increase from £725 to £4,839 PER YEAR.

NHS Planning Guidance 2016/17 – 2020/21

At the end of December NHS England released its planning guidance to Commissioners.

This 32 page document is not the most thrilling read, filled with NHS-speak and mandating Commissioners and providers to deliver the goals set out in the Five Year Forward View.

Reading between the lines, a softening of the stance on general practice has been noticed. Most notably and, hopefully, encouragingly, it sets out 9 national 'must dos' for 2016/17 number three is "Develop and implement a local plan to address the sustainability and quality of general practice, including workforce and workload issues". This gives us opportunity to work with local commissioners further influence to sustainability of primary care in LLR.

National GP Induction and Refresher scheme

There is a bursary of up to £2,300 per month for doctors applying from overseas to work as a GP.

The scheme provides an opportunity to GPs who have previously been on the GMC register and the National Performers List, to return to general practice after a career break, raising a family or working abroad. It also supports the safe introduction of overseas GPs who have qualified overseas and have no previous NHS experience. Doctors can apply from overseas, before they return or come to the UK. In addition to the financial bursary, participants are given a supervised placement in general practice via Health Education England.
