D. LEARNING AND SHARING FROM NHS ENGLAND COMPLAINTS TEAM

The NHS England complaints team, Cathie Cunnington (Complaints Manager, NHSE) has shared August's key learning points that would be beneficial for the wider GP Community:

- Consider a review of repeat prescribing policies to minimise the risk of medication being missed off repeat prescriptions.
- Review complaints handling procedures to ensure complaints are managed in line with current NHS Complaints Regulations.
- Consider contacting patients before withdrawing medication from repeat prescribing lists.

E. QUESTION TIME...

F. PHARMACY IMPLANTS- GP SURVEYORS

They will sometimes offer to pay large premiums to GP surgeries in order to secure space in their premises. However, this is sometimes in exchange for a lower rent. The financial impact of this premium is likely to be very short term, eventually leaving the surgery out of pocket over the 15 – 25-year lease term. A specialist can negotiate a happy medium.

Step 4: Action Rent Reviews

Your specialist surveyor should ensure that there are appropriate rent review provisions set out within the lease. It is in your interests to action all rent reviews as the value of pharmacies are generally on the up. If you have missed a review, it may be possible to back track and receive backdated rental increases.

Step 5: Monitor your Patient List Size

If valued correctly, taking into account the profits gained from prescriptions issued by your surgery, the value of the pharmacy will increase if your patient list size increases. Therefore, increasing your patient list size could boost the rent that your pharmacy has to pay. Your specialist surveyor will assess the situation for you and negotiate a rental increase where possible.

SHARED LEARNING AND KEY ISSUES RAISED WTH THE LMC THIS MONTH:

The LMC would like to share with our members some of the queries that have been asked of the LMC over the last month, to share learning and information.

- Practice Mergers:

Recently, the LMC have received queries re. what to do if a practice is thinking about merging with another. LMC Response:

Before announcing merger to the wider public, talk to your PPG and seek support to the principle of merging. If you are rolling out more services over longer hours, therefore improving patient access, it is easier to pitch as everyone will benefit but you may need to undertake a full public consultation if there is a net loss to services through premises being closed, which the Area Team will be able to guide you through. - Sickness cover for GP/Reimbursement costs for cover:

Some of our levy payers have sought advice regarding the above topic and what their rights are as a practice. <u>LMC Response:</u>

Practices are currently at considerable financial risk of paying for sickness absence of GP's due to discretionary reimbursement, outdated list-size criteria and the need for cover to be provided by an external locum.

The LMC have secured that sickness cover reimbursement will no longer be a discretionary payment, but a practice entitlement. The qualifying criteria based on list-size, which often prevents a practice from being able to claim payment to cover locum costs, has been removed.

- Checklist for New Partners:

Lately, there have been advice requests on what practices should consider when a new partner joins their practice. LMC Law have compiled a <u>list of what practices</u> <u>should take into account</u> when taking on a new partner.

- Private Prescription Charges:

The LMC have received multiple queries regarding private prescription charges. Do practices have the right to charges patients for this service?

<u>LMC Response</u>: The BMA guidelines state that practices should NOT be charging for private prescriptions unless they fall into the remit on the BMA <u>Guidance</u>.

Many of our levy payers may have seen this guidance but it states "Can I charge for issuing a private prescription? No. GPs can write private prescriptions for patients which they may wish to do particularly in relation to drugs not available through the Drug Tariff, however, GPs cannot charge for providing such a prescription. The only occasion when a doctor can charge for a private prescription is in relation to travel overseas."



National:

I. UPDATE FOR PRACTICES IN NHSPS AND CHP PREMISES

The GPC has released updated information for practices.

"Regarding the ongoing issues with NHS Property Services (NHS PS) and Community Health Partnerships (CHP). We are aware that a written question was submitted to the Secretary of State (SoS) about money owed to NHSPS and CHP by GPs, and that this has now been covered by Pulse.

We want to reiterate to LMCs and practices our previous guidance on this issue. In respect of current charges, practices should only make payments to both the extent that they are both satisfied as to the legal basis upon which they are payable and their accuracy.

GPC are aware that this issue is causing practices significant stress, and we would like to reassure you that GPC will stand with you in circumstances where, despite there being no legal basis to do so, NHSPS seek to enforce these charges. M. GPC NEWS

GPC England held its meeting on Thursday 19 July. The following issues were discussed at the meeting:

The GP Partnership Review:

Update given from Dr Nigel Watson (GPC member and Chief Executive of Wessex LMC) who is leading an independent review into the partnership model of General Practice.

The QOF Review Report:



Discussion of report "Review of Quality and Outcomes Framework (QOF) In England."

GPC has been working with NHS England, RCGP and others to review QOF and expect the report to stimulate further discussion.

Our intention is that any changes to QOF must provide stability for practices and better enable them to respond to the needs of their patients.

NHSE Consultation- Digital First Funding:

The committee also discussed the BMA's draft response to the NHS England's consultation on digital-first primary care and its implications for general practice payments. While it was recognised that there are the many advantages that technology and innovation can provide for general practice, there is serious concern about the model used by providers, such as GP at Hand.

General Data Protection Regulation (GDPR):

Data Protection Officers and GP practices under GDPR A DPO has formal responsibility for data protection compliance within an organisation.

The appointment of a DPO under the EU General Data Protection Regulation (GDPR) is only mandatory when the organisation is a public authority or body, or when the organisation's core activities consist of either:

- Data processing operations that require regular and systematic monitoring of data subjects on a large scale; or
- Large-scale processing of special categories of data (i.e. sensitive data such as health, religion, race, sexual orientation, etc.) and personal data relating to criminal convictions and offences
