Struggling Practice Fund

At long last NHS England has published guidance to commissioners as to how practices can access the Struggling Practice

There is £812,509 earmarked for the entire Central Midlands region, with practices needing to meet specific criteria to access funding. The LMC will be working closely with the three CCGs and NHS England to ensure our practices are able to benefit from this funding.



LMC Special Conference - 30 January 2016

The General Practitioners Committee has agreed to hold a special conference for Local Medical Committees on 30 January, to decide what actions are needed to ensure GPs can continue to deliver a safe and sustainable service. This was voted for overwhelmingly following calls from LMCs across the country, including your LMC here in LLR, as a vital opportunity to draw attention at the highest level of the crisis General Practice finds itself in.

We are sending 6 GP representatives from the Committee. We hope this conference receives the national media attention it deserves - LMCs from across the country will be calling for serious actions to address the neglect and underfunding of general practice.

Request from the General Practitioners Committee for practices to respond to survey on GP workload pressures:

"Dear colleague

Following sustained lobbying by the BMA General Practitioners Committee (GPC), the unprecedented pressures faced by GP practices are at last being recognised by politicians, policy makers and the media.

As part of a range of activities, we are looking at new ways to illustrate some of the current issues. This will include an online map to be published on the BMA website, highlighting areas of England, Scotland and Wales where practices are struggling with workload, recruitment, retention and financial viability. The map will help to show the current state of general practice and quantify the scale of the problems faced.

We are therefore asking practices to complete a short online survey that will take <u>less</u> than two minutes to complete, via this link: https://www.surveymonkey.co.uk/r/KSZJN37

Practices are also asked to provide their post code and the name of their CCG or Health Board so that responses can be mapped across CCG/Health Board areas and parliamentary constituencies. Please note that no individual practices will be identified.

We are seeking <u>one</u> response per practice, and will need to receive all responses by **Wednesday 23 December.**
